(Jurisdiction of officers for Sahiwal Commissionerate)

No. PRA/Orders.06/2017.Vol(V)/1081 : In exercise of powers conferred under subsection (1) & (6) of Section 39 of the Punjab Sales Tax on Services Act 2012 (Act XLII of 2012) read with section 40 thereof, the Punjab Revenue Authority is pleased to assign the powers and functions as provided at column (III) of the table below, exercisable or to be exercised under the said Act and rules made, notifications of circulars issued or instructions given there under, to the officers holding the charge of the units specified in column (II) of the table below in respect of persons or class of persons or cases or class of cases or services as specified in column (IV) of the said table, with immediate effect and till further orders.

2. The aforementioned Additional Commissioner/Enforcement Officer shall also be responsible from initiation of appeals/writs, preparation of legal defence and timely appearance before relevant appellate forum in consultation with the legal wing of PRA Head Office, Lahore.
3. The Additional Commissioner shall exercise all the powers & functions provided in column (III) of the above table in respect of both the service providers and withholding agents falling within Sahiwal Commissionerate in respect of all services mentioned in Second Schedule to Punjab Sales Tax on Service Act, 2012 (as amended and amendable from time to time), however, subject to their pecuniary limits as defined in Section 60 of the Punjab Sales Tax on Services Act, 2012.
4. The Enforcement Officer shall exercise all the powers & functions provided in column (III) of the above table in respect of both the service providers and withholding agents falling within Sahiwal Commissionerate in respect of all the services mentioned in Second Schedule to Punjab Sales Tax on Service Act, 2012 (as amended and amendable from time to time), however, subject to the condition that their pecuniary limit in terms of section 60 (1) (d) of the Punjab Sales Tax on Services Act, 2012 shall not exceed one million rupees.
5. The Additional Commissioner and Enforcement Officer, in addition to their functions, shall also perform such official duties and functions as may be assigned to them by the concerned Commissioner, Member or Chairperson, PRA.
6. The Enforcement Officer, in addition to his functions, shall also perform such duties or function as may be assigned to him by Additional Commissioner in the Sahiwal Commissionerate.
