



Bids shall be valid for a period of 90 days after bid opening and must be accompanied by bid security at least 2% of the estimated price in the form of Call Deposit Receipt in favour of Additional Commissioner (HQs), PRA and must be delivered to the above office at or before 03:00 PM on or before 18-01-2018 at the above office.
4. The bids shall be opened in the presence of the bidders / representatives who may choose to attend at 3:30 PM on 18-01-2018 at the above office.
5. Evaluation will be carried out and contract will be awarded subsequently.
6. Ten percent of the total price will have to be submitted as security / performance guarantee in the form of CDR/ Bank guarantee (as the case may be) in case of acceptance of tender, otherwise tender will be rejected.
7. All rates must be inclusive of all taxes.
