


TENDER NOTICE / INVITATION FOR BIDS

2. The terms & conditions are as under:-

1. The companies / firms must be registered with the General Sales Tax & Income Tax Departments
2. Bidding documents may be purchased from the office of Punjab Revenue Authority 5-B Danepur Road, GOR-1 Lahore (Phone No. 042-99205457, Fax No.042-99205489 e mail after production of original challan,form of payment made in the NBP / SBP under head C03870- Others for a non refundable fee of Rs.1,000/- for each set within 15 days from the date of publication within office hours. Interested bidders may obtain further information at the same address.
3. Bids shall be valid for a period of 90 days after bid opening and must be accompanied by bid security at least 2% of the estimated price in the form of Call Deposit Receipt in favour of Additional Commissioner (HQs), PRA and must be delivered to the above office at or before 04:00 PM on 18.05.2018 or before at the above office.
4. The bids shall be opened in the presence of the bidders / representatives who may choose to attend at 4:30 PM on 18.05.2018 at the above office.
5. Evaluation will be carried out and contract will be awarded subsequently.
6. 10% of the total price will have to be submitted as security / performance guarantee in the form of CDR/ Bank guarantee (as the case may be) in case of acceptance of tender, otherwise tender will be rejected.
7. All rates must be inclusive of all taxes.
8. The Authority will be authorized to deduct tax as per prevalent rate.
9. The bidders should give their best and final price in their bids as no post bid negotiations are allowed.
10. As provided in the bidding document, the bidders engaged in corrupt or fraudulent practices (including collusion / polling) will be declared ineligible, either indefinitely or for a certain period.
11. The bidders shall finally sign (and include in the bid) the Standard Form, Bid Form and Price Schedule given in the bidding document.
